

## **PIXICADE SOCIAL MEDIA SWEEPSTAKES OFFICIAL RULES**

This Pixicade Social Media Sweepstakes (“Sweepstakes”) is sponsored by BitOGenius Inc., 333 Mamaroneck Ave PMB 394, White Plains NY 10605 United States, [press@bitogenius.com](mailto:press@bitogenius.com) (“Sponsor”) and is open to all natural persons who are legal residents of the 50 United States and District of Columbia, who are at least thirteen (13) years old at time of entry. Void outside of the USA, in Puerto Rico, the US Virgin Islands and other US territories and protectorates. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law.

### **1. THE SWEEPSTAKES**

- A. **HOW TO ENTER:** You can enter the Sweepstakes by following the directions listed on the Pixicade Sweepstakes posts on Facebook and Instagram. Limit one (1) entry per person per email account during the Entry Period regardless of method of entry. Any person found to be inaccurately tagging content, using bots, services, or other unethical methods to increase their chances of winning will forfeit their entry. By entering the Sweepstakes, you grant Sponsor the right to publicly post your name and/or social media handle(s) in the event that you are selected as the winner. An entry will be discarded if the person has won a Pixicade Sweepstakes within the prior six (6) month time frame.
- B. **ENTRY PERIOD:** The Sweepstakes begins and ends on the dates listed on the Pixicade Sweepstakes posts on Facebook and Instagram (the Entry Period). Entries that are submitted before or after the Entry Period will be disqualified. For the purposes of these Official Rules, all times are Eastern Standard Time.
- C. **PRIZE.** The prize will be one (1) Pixicade Mobile Game Maker Kit with a retail value of approximately \$24.99. The prize will be shipped to the address provided by the winner via USPS or other domestic shipping service. There is no option to trade in the prize for an equivalent cash value.
- D. **RANDOM DRAWING & WINNER NOTIFICATION:** Within twenty-four (24) hours of the close of the Entry Period, one (1) winner will be selected randomly from all valid entrants. The winner of the Sweepstakes will be posted publicly on the Pixicade social media accounts upon selection of the winner. The Sweepstakes winner will also be notified within one (1) hour of the public winner announcement posted on the Pixicade social media pages. The winner will also receive winner announcement via private message, direct message, or email based on the form of entry. The winner will have two (2) days (forty-eight (48)) hours to respond to the private communication from Sponsor else they forfeit the prize. If a prize is forfeited, Sponsor will randomly select a second winner. If a second winner does not come forward, Sponsor will select a third and final winner at random. If the third winner does not claim the prize, Sponsor will donate the prize to a local children’s charity.
